2. AAS – Criminal Justice Technology – Program Change Robert Stanberry Presenting: The current degree plan has 4 slots within the degree that require criminal justice courses. Two of those have previously only allowed for ACGM coursework. The CRT and Advisory Board agreed to expand those two slots to include WECM courses as well as to narrow one of the four slots to CJ prefix only courses or LGLA 2337. The last change included increasing the options for the Social and Behavioral Science elective to include SOCI 2336 as a way to align the degree plan with current Core Curriculum courses. April Kinkead moved to approve degree change and Michelle Trubenstein seconded.
