NEW BUSINESS:

- **AKA**

1. Program Change: AA Communication Studies – This change is to update the Advising notes and course notations to align the degree with the revised Field of Study for Communications.

- **ATWED**

The following proposals are to create new Institutional Certificates Leading to Credentials (ICLC) for workforce areas already in existence. This will bring Blinn's Workforce credentials into alignment with the new guidelines for ICLC found in the CTE Manual for the THECB.

1. New ICLC: Highway Technician
2. New ICLC: CNA Non-credit
3. New ICLC: Certified Clinical Medical Assistant
4. New ICLC: Certified Medical Administrative Assistant
5. New ICLC: Dietary Manager
6. New ICLC: Medication Aide
7. New ICLC: Pharmacy Technician
8. New ICLC: Phlebotomy
9. New ICLC: Professional Truck Driver

- **Health Sciences**

1. New ICLC: CNA Dual Credit
2. New ICLC: EMT Basic

3. Program Change: AS in Health Sciences – Nursing. This change includes adjusting the class options for the Core Curriculum LPC area to include any core course rather than just PHIL 2306. This change was approved by the CRT for the program.
4. Program Change: AAS Emergency Medical Services. This changes the Core Curriculum Math requirement to any core math degree to make the degree more accessible to students. This update was approved by the Advisory Council for this program.

- **Humanities**

1. Program Change: AS in Education. In July 2024, three Education Fields of Study (FOS) were approved by the THECB for the EC-3, EC-6 and 4-8 Core Subject certification levels. All three of these FOS are lower-division courses that transfer and apply to an associates degree program, streamlining transferability for students entering teacher education degree programs at the 4-year institution level. The changes to course notation within this degree will allow it to include all three FOS within the degree. All changes were approved by the Education CRT.
2. Program Deletion: Associates of Arts Teaching (AAT), Option A. With revisions to the AS Education and three Education FOS, this degree is not the best option for students interested in early education certifications and the AAT Option B would cover those interested in middle school or EC-12 education.
3. Program Change: Associates of Arts Teaching (AAT), Option B. With the removal of the AAT, Option A, we wish to rename the AAT – Option B to the AAT – Secondary Education and Content Area Teaching.
4. Course Change: EDUC 1301 - The EDUC 1301 course description in the ACGM has been modified to indicate that the field experience for this course may be provided through videos or other technology.
5. Course Change: EDUC 2301 - The EDUC 2301 course description in the ACGM has been modified to indicate that the field experience for this course may be provided through videos or other technology.
